INFORMATION

This Privacy Policy is to inform the user (hereinafter the “User”) that the personal data he/she provides through the portal located at the URL www.teka.com/global/ (hereinafter the “Declaration Portal”), will be processed by TEKA, in accordance with the Regulation (EU) 2016/679 (General Data Protection Regulation).

We hereby inform the user that KUPPERSBÜSCH is a registered trademark property of TEKA INDUSTRIAL S.A.

COMPULSORY DATA

The data requested on the form of the Declaration Portal is compulsory in order to fulfil the purposes for which it is being collected, namely, to provide the legally requested declaration. Accordingly, if the data is not provided or is not provided correctly, it will not be possible to fulfil the User’s declaration.

PURPOSE

The personal data will be processed by TEKA for the purpose of managing, controlling and communicating to the EU Official Authorities the product’s declaration submitted in compliance with the legally established obligations.

PERSONAL DATA

TEKA will only process the following personal data of the User:

- **Identification data:** name and surname

- **Contact details:** e-mail address

When the User provides data of third parties, he/she states that he/she has obtained the consent of such third parties and/or has sufficient authority to do so and undertakes to convey to such third parties the information contained in the Privacy Policy, releasing TEKA from any liability in this regard.

However, TEKA may carry out the pertinent verifications to confirm this fact, by adopting the corresponding due diligence measures in accordance with data protection legislation.

LEGAL BASIS FOR THE PROCESSING OF THE PERSONAL DATA

The legal basis for the processing of the personal data requested by TEKA is the compliance with legal established obligations.

CONSERVATION OF DATA

The Personal Data will be stored by TEKA during the term established by law.

RECIPIENTS

The personal data may be communicated to:

- Public Authorities, in the cases established by law, based on compliance with a **legal obligation**.
- Courts, in the cases established by law, based on compliance with a **legal obligation**.
- Companies that belong to the same group as TEKA, for administrative and business management purposes, based on the **legitimate interest** recognized in Recital 48 of the GDPR.

Personal data will not be communicated to third parties other than the cases specified above, without the written specific consent of the user.

SECURITY MEASURES

TEKA will process the User's data in an absolutely confidential manner at all times and respecting the mandatory obligation of secrecy in respect of such data, in accordance with the provisions of the applicable legislation, adopting for that purpose the necessary technical and organization measures to assure the security of his/her data and prevent the alteration, loss, unauthorized access to or processing of such data, with regard to the state of the art, the nature of the data stored and the risks to which they are exposed.

EXERCISE OF RIGHTS

As data subject, the user can exercise the rights of access, objection, rectification, erasure, limitation, and portability, by writing to TEKA at the address indicated at the beginning of this Privacy Policy, or sending an e-mail to: mail@teka.com, attaching a copy of his/her identity document, at any time and free of charge. If the user considers that its rights have not been fully satisfied, it can submit a complain to the corresponding national authority.
